

## **Privacy Statement**

Walsh Consultants Pty Ltd is committed to protecting your privacy and developing technology that gives you the most powerful and safe online experience. This Statement of Privacy applies to the Givewell Web site and governs data collection and usage. By using the Givewell website, you consent to the data practices described in this statement.

### **Collection of your Personal Information**

Walsh Consultants Pty Ltd collects personally identifiable information, such as your e-mail address, name, home or work address or telephone number. Walsh Consultants Pty Ltd also collects anonymous demographic information, which is not unique to you, such as your postcode, age, gender, preferences, interests and favourites. There is also information about your computer hardware and software that is automatically collected by Walsh Consultants Pty Ltd. This information can include: your IP address, browser type, domain names, access times and referring Web site addresses. This information is used by Walsh Consultants Pty Ltd for the operation of the service, to maintain quality of the service, and to provide general statistics regarding use of the Givewell website. ### **Use of your Personal Information**

Walsh Consultants Pty Ltd collects and uses your personal information to operate the Givewell Web site and deliver the information you provide to the service providers and/or potential customers you have requested. Walsh Consultants Pty Ltd also uses your personally identifiable information to inform you of other products or services available from Walsh Consultants Pty Ltd and its affiliates. Walsh Consultants Pty Ltd may also contact you via surveys to conduct research about your opinion of our current services or of potential new services that may be offered. Walsh Consultants Pty Ltd does not sell, rent or lease its customer lists to third parties. Walsh Consultants Pty Ltd may, from time to time, contact you on behalf of external business partners about a particular offering that may be of interest to you. In those cases, your unique personally identifiable information (e-mail, name, address, telephone number) is not transferred to the third party. In addition, Walsh Consultants Pty Ltd may share data with trusted partners to help us perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to Walsh Consultants Pty Ltd, or to you at your explicit request, and they are required to maintain the confidentiality of your information. Walsh Consultants Pty Ltd does not use or disclose sensitive personal information, such as race, religion, or political affiliations, without your explicit consent. Walsh Consultants Pty Ltd keeps track of the websites and pages our customers visit within Celebrant Supreme, in order to determine what Walsh Consultants Pty Ltd services are the most popular. This data is used to deliver customised content and advertising

within Givewell to customers whose behaviour indicates that they are interested in a particular subject area. Walsh Consultants Pty Ltd websites will disclose your personal information, without notice, only if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on Walsh Consultants Pty Ltd or the site; (b) protect and defend the rights or property of Walsh Consultants Pty Ltd; and, (c) act under exigent circumstances to protect the personal safety of users of Walsh Consultants Pty Ltd, or the public.

#### Use of Cookies

The Givewell website uses "cookies" to help you personalise your online experience. A cookie is a text file that is placed on your hard disk by a web page server. Cookies cannot be used to run programs or deliver viruses to your computer. Cookies are uniquely assigned to you, and can only be read by a web server in the domain that issued the cookie to you. One of the primary purposes of cookies is to provide a convenience feature to save you time. The purpose of a cookie is to tell the web server that you have returned to a specific page. For example, if you personalise Givewell pages, or register with Givewell site or services, a cookie helps Walsh Consultants Pty Ltd to recall your specific information on subsequent visits.
